

ORDINANCE NO. _____

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG REPEALING ORDINANCE NO. 1391-11 ENACTED ON OCTOBER 11, 2011 RELATIVE TO THE ESTABLISHMENT OF A RECREATION BOARD.

WHEREAS, by Ordinance No. 1391-11, enacted on October 11, 2011, the Borough Council of the Borough of Gettysburg established a Recreation Board with all of the powers and subject to all of the responsibilities of a recreation board consistent with Article XXVII of The Borough Code; and

WHEREAS, by Ordinance No. 1410-13, enacted on May 14, 2013, the Borough Council of the Borough of Gettysburg established a joint recreation authority with Cumberland Township for the purpose of the operation and maintenance of recreation places within the Borough of Gettysburg consistent with the powers and subject to the requirements of the Pennsylvania Municipality Authorities Act, 53 Pa. C.S. § 5601 et seq. and

WHEREAS, on June 7, 2013, the Gettysburg Area Recreation Authority was chartered as a municipal authority and a Certificate of Incorporation was issued by the Pennsylvania Department of State, Department of Corporations and Charitable Organizations; and

WHEREAS, it is the intention of the Borough Council of the Borough of Gettysburg to enact an ordinance of the Borough of Gettysburg repealing Ordinance No. 1391-11 enacted on October 11, 2011 establishing a Recreation Board for the purpose of dissolving and disbanding the Recreation Board of the Borough of Gettysburg and thereby confirming the authority of the Gettysburg Area Recreation Authority to operate, supervise and maintain recreation places within the Borough of Gettysburg.

NOW, THEREFORE, the Borough Council of the Borough of Gettysburg hereby enacts, adopts and ordains the following:

SECTION 1: Ordinance No. 1391-11, enacted on October 11, 2011, establishing a Recreation Board for the Borough of Gettysburg, is hereby repealed for the purpose of dissolving and disbanding the said Recreation Board.

SECTION 2: Consistent with Ordinance No. 1410-13, enacted on May 14, 2013, 2013, the authority to operate, supervise and maintain recreation places within the Borough of Gettysburg is and shall be vested in the Gettysburg Area Recreation Authority.

SECTION 3: All other ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4: This ordinance shall take effect upon enactment.
