**AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, TO BE ENACTED FOR THE PURPOSE OF AMENDING THE RESIDENTIAL PARKING PERMIT SYSTEM ORDINANCE OF THE BOROUGH OF GETTYSBURG BY REMOVING AN AREA ON THE EAST SIDE OF SOUTH FRANKLIN STREET FROM THE RESIDENTIAL PARKING PERMIT SYSTEM.**

The Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, hereby enacts, adopts and ordains this Ordinance amending Chapter 15, Part 10, Section 1003, subsection 1. of the Code of Ordinances of the Borough of Gettysburg as follows:

**SECTION 1:** Chapter 15, Part 10, Section 1003, subsection 1 shall be amended in part by removing an area on the east side of South Franklin Street from those streets or portions of streets designated as residential parking permit streets. The area on South Franklin Street to be removed from the residential parking permit system is comprised of eight (8) parking spaces between West High Street and West Middle Street. The current residential parking permit street designation, which ordinance provision will be deleted, reads as follows:

**§15-1003. Designation.**

1. The following are designated as residential parking permit streets:

<b>Street</b>	<b>Between</b>
South Franklin Street	West High Street and West Middle Street

**SECTION 2:** Following the enactment of this ordinance and upon the date this ordinance will take effect, the two (2) areas of South Franklin Street remaining as parts of the residential parking permit system of the Borough of Gettysburg shall be: a) an area on the east side of South Franklin Street between Breckenridge Street and West High Street; and b) an area comprised of two (2) parking spaces on the east side of South Franklin Street between its intersection with West High Street and its intersection with West Middle Street. Such areas which will remain as parts of the residential parking permit system on the east side of South Franklin Street shall be specifically designated in Chapter 15, Part 10, Section 1003 as follows:

**§15-1003. Designation.**

1. The following are designated as residential parking permit streets:

**Street**

**Between**

South Franklin Street (east side only)

Breckenridge Street and West High Street

South Franklin Street (two parking spaces on east side only)

West Middle Street and a point 89.2 feet south of its intersection with West Middle Street

**SECTION 3:** All remaining provisions of Chapter 15, Part 10, Section 1003 shall remain in full force and effect unless otherwise repealed by any other ordinance. All other ordinances and parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4:** This ordinance shall take effect on September 1, 2016.
